TERMS & CONDITIONS FOR USE OF RCPL MARK OF CERTIFICATION

Use of the ROBUST CERTIFICATIONS PRIVATE LIMITED / RCPL mark of Certification is subject to the conditions detailed below -

1. RCPL mark of certification has to be used along with certificate number, put just below the mark covering space not broader than the mark, and as such it can be used only by those organizations, which possess a valid certificate of registration, issued by RCPL in their name.
2. Use of mark of certification is restricted to correspondence, advertisement, and promotional material that is directly applicable to the scope of Certification / registration as shown on the certificate.
3. The CB does not permit its marks to be applied to laboratory test, calibration or inspection reports, as these reports are service results / products of the organizations.
4. Use of mark is allowed only on material not integrated with the product. If it is used on the product packing, the packing must be detachable from the product. The mark of certification on such detachable packing must accompany certification statement denoting that the certification is for the management system.
5. The certification statement if used, shall in no way imply that the product, process or service has been certified. The statement shall include only reference to –
 - identification (e.g. brand or name) of the certified client;
 - the type of management system (e.g. quality, environment) and the applicable standard;
 - the certification body issuing
6. The RCPL mark of certification should not be used in such manner as to allude that the product or service has been certified by the RCPL. It is only the management system that has been certified.

8. The RCPL mark of certification may be enlarged or reduced aesthetically depending upon space available, for example on boards or hoardings the mark size can be enlarged , while on letter heads or stationeries, or visiting cards logo size can be appropriately reduced.
9. If violated, RCPL reserves the right to revoke/ suspend/ withdraw the registration certificate until the infringement has been nullified. Legal action will be taken under section 406 IPC which is breach of contract/trust and carries a punishment of imprisonment for 3 years, or appropriate financial penalty or both.
10. RCPL mark of certification is covered under the trademark act 1999, Unauthorized use of mark is punishable under section 23 (2) rule 62 (!) .
